TWENTY-EIGHTH AMENDMENT TO DECLARATION
OF RESTRICTIONS AND PROTECTIVE COVENANTS
FOR RIVER HILLS GOLF AND COUNTRY CLUB AND
AMENDMENT TO THE ARB STANDARDS MANUAL

This Twenty-Eighth Amendment to Declaration of Restrictions and Protective Covenants for River Hills Golf and Country Club, and Amendment to the Architectural Review Board Standards Manual executed this 5th day of November, 2021.

WHEREAS, On May 13, 1988, the Declarant recorded its Declaration of Restrictions and Protective Covenants for River Hills Golf and Country Club dated March 21, 1988, in Deed Book 1218 at page 001, records of Horry County, as amended (the "Declaration"), and the Architectural Review Board Standards Manual as Revised on September 8, 2018 and recorded at Deed Book 4175 at page 2021, records of Horry County; and

WHEREAS, ARTICLE XVI, Section 2 of the Declaration provides that the Declaration may be amended by an instrument signed by the Owners of not less than 51% of the lots; in a duly held meeting on September 25, 2021, with a quorum present, Fifty-One (51%) percent of the Owners voted to amend the said Declaration; and

WHEREAS, ARTICLE IX of the Declaration provides that the Architectural Review Board may promulgate rules and regulations as it deems necessary; and

NOW THEREFORE, in accordance with ARTICLES IX and XVI of the Declaration, the Owners hereby make the following amendments:

As to the Declaration:

ARTICLE X, USE RESTRICTIONS is amended to add the following section:

Section 25. Short-term rentals are prohibited, including daily, weekly, monthly ("hoteling") rentals. Long-term rentals, defined as twelve (12) months or longer are allowed. The owner of the property shall provide a copy of the lease agreement to the Board of Directors prior to occupancy for each lease term.

As to the ARB Standards Manual:

The section entitled <u>Renovations/Alterations/Landscaping</u>: <u>Property Owner/contractor Performance Deposit</u>, on the bottom of page 5, is amended to delete the first sentence and, in its place, add the following sentence:

Imposed at the discretion of the ARB, used to ensure that the property owner/contractor, during construction, keeps the property in a neat, clean, workmanlike manner.

All other terms and conditions of the Declaration and ARB Standards Manual described above shall remain unchanged.
